Exploring Urban Planning Data: Insights from APA, ACSP, and PAB



At the 2024 ACSP Annual Conference, a data sharing session was hosted by the American Planning Association (APA), Association of Collegiate Schools of Planning (ACSP), and the Planning Accreditation Board (PAB). This session marked the first joint data presentation between the APA, ACSP, and PAB, bringing together valuable insights from all three organizations and setting the foundation for continued collaboration and sharing of joint data in the future.

• APA presented analyzed membership trends and characteristics across its members (including student and faculty members), AICP members, and AICP exam takers. "A key takeaway from presenting alongside ACSP and PAB and comparing datasets was the realization of significant gaps in our understanding of the planning profession. Despite the wealth of data collected, there remain unanswered questions about the pathways into the profession, the diversity of career experiences, and the evolving needs of planners in different contexts. Addressing these gaps is critical to fostering a more inclusive, resilient, and forward-thinking profession, enabling planners to create great communities for all and adapt to future challenges." - ACSP focused on the spatial distribution of member schools and their full-time faculty, the number of programs by state, minority-serving institutions, trends in the number of papers presented in planning research tracks, and the STEM classification of programs.
- PAB presented on data collected from the annual reports of accredited planning programs. This included the spatial distribution of programs and their student enrollments, the demographic composition of students from 2014 to 2023, the percentage of graduates employed in planning-related jobs within a year of graduation, and the number of faculty with AICP certification.

AICP Certification Exam Content Areas

Student performance on each AICP Certification Exam Content Area is provided in the exam list. Review student scores in columns I-Q against the average number of questions per content area to see how your program's curriculum prepares its students in Research and Assessment Methods, Fundamental Planning Knowledge, Communication and Interaction, Plan and Policy Development, Plan Implementation, Administration and Management, Leadership, Areas of Practice, & AICP Code of Ethics and Professional Conduct.

New PAB Guidance - Student Learning Outcomes Assessment

PAB recently developed guidance to provide additional clarification on the expectations related to criterion 4D. Student Learning Outcomes Assessment. This resource, <u>available on the PAB website</u>, will ensure consistency of review and assessment among Site Visit Team members, and board members.

APA is actively working on two projects, Future Planners Project and the Planning Sector Data Project, to improve our understanding of the profession. The first project involves a survey to collect data on compensation, benefits, and workplace characteristics across the planning profession, offering insights into who planners are, where they work, and how much they earn. We encourage your participation in the survey and request that you share it with your alumni networks. The second project focuses on gathering secondary data to identify trends and gaps related to enrollment, completion, attrition, and post-completion employment in planning programs. Your support is crucial here as well—please share any program data on these topics. You will receive communication about these projects through APA, ACSP, PAB, or potentially multiple channels. Your input is invaluable and will help us better understand our profession.
